AKTA INSOLVENSİ RENTAS SEMPADAN 2026

PERINTAH INSOLVENSİ RENTAS SEMPADAN (PENETAPAN NILAI AMBANG) 2026

PADA menjalankan kuasa yang diberikan oleh subseksyen 21(3) Akta Insolvensi Rentas Sempadan 2026 [*Akta 877*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Insolvensi Rentas Sempadan (Penetapan Nilai Ambang) 2026**.

(2) Perintah ini mula berkuat kuasa pada 28 Ogos 2026.

2. Menteri menetapkan suatu amaun yang tidak melebihi dua ratus ribu ringgit sebagai nilai ambang bagi tuntutan pemiutang di Malaysia.

CROSS-BORDER INSOLVENCY ACT 2026

CROSS-BORDER INSOLVENCY (PRESCRIPTION OF THRESHOLD) ORDER 2026

IN exercise of the powers conferred by subsection 21(3) of the Cross-Border Insolvency Act 2026 [*Act 877*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Cross-Border Insolvency (Prescription of Threshold) Order 2026**.

(2) This Order comes into operation on 28 August 2026.

Prescribed amount

2. The Minister prescribes an amount not exceeding two hundred thousand ringgit as the threshold for the claims of creditor in Malaysia.
